

MUSC SKINCEUTICALS INDUSTRY FELLOWSHIP BROCHURE

The one-year post-doctoral fellowship is designed to develop the knowledge, skills, and behaviors required for a field-based medical affairs position. A significant portion of the fellowship program is spent with SkinCeuticals gaining hands-on experience regarding the industry and Medical Affairs. The fellowship will prepare candidates for any field-based medical professional position within industry. (85%)

- Build a strong foundational background in the dermatologic therapeutic area and learn how to effectively communicate advanced scientific data on clinical research, disease state awareness, pipeline assets, and therapeutic trends in a fair balanced manner.
- Work in the field with a Medical Affairs mentor to gain skills in effective communication of scientific data, application of medical strategy, and development of scientific partnerships with practitioners in dermatology.
- Gain an understanding of Medical Affairs including thought leader (TL) engagement planning, territory management and the art of developing and fostering relationships with critical stakeholders, TLs, Health Care Professionals (HCPs) and institutions.
- Establish collaborative relationships with internal colleagues in various departments within SkinCeuticals/L'Oréal, as well as external colleagues.
- Learn medical trends and contribute actively to team projects of high impact to the medical team.
- Attend and actively participate in relevant scientific and professional meetings, including major medical meetings, SkinCeuticals/L'Oréal Advisory Boards, and peer to peer education.

- Participate in the review process and discussion strategy for Investigator Initiated Trials (IIT) as well as Company Sponsored Studies (CSS).
 - Creating, updating, and reviewing fair and scientifically balanced responses to unsolicited medical inquiries.

ABOUT MUSC and the College of Pharmacy

Founded in 1824 in Charleston, MUSC is home to the oldest medical school in the South as well as the state’s only integrated academic health sciences center, with a unique charge to serve the state through education, research and patient care. Each year, MUSC educates and trains more than 3,000 students and nearly 800 residents in six colleges: Dental Medicine, Graduate Studies, Health Professions, Medicine, Nursing and Pharmacy. MUSC brought in more than \$327.6 million in biomedical research funds in fiscal year 2021, continuing to lead the state in obtaining federal and National Institutes of Health funding, with more than \$220 million. In 1881, the Medical College created a Department of Pharmacy that was the first of its kind in the Deep South. The Pharmacy program admitted its first students in 1882, discontinued after two years, then resumed on a permanent basis in 1894, offering the degree of graduate in pharmacy (Ph.G.).The program leading to a degree of bachelor-of-science in pharmacy began in 1936. The doctor of pharmacy (Pharm.D.) program began in 1973 (post-baccalaureate) and a Ph.D. program in pharmaceutical sciences was initiated in 1982 (the latter administered through the MUSC College of Graduate Studies in collaboration with the University of South Carolina). MUSC transitioned to the entry-level Pharm.D. degree in 1997. Today, the College of Pharmacy (<https://pharmacy.musc.edu>) on the MUSC campus boasts a student body of 300 students in the Pharm.D. program. The College offers a concurrent Pharm.D./MBA degree with The Citadel Graduate College and a Pharm.D./Ph.D. In addition, the MUSC Medical Center and College of Pharmacy Residency Program offers one of the largest and most respected pharmacy residency programs in the country with 12 specialty tracks and typically 30 residents. The College of Pharmacy also offers an industry fellowship with SkinCeuticals.
